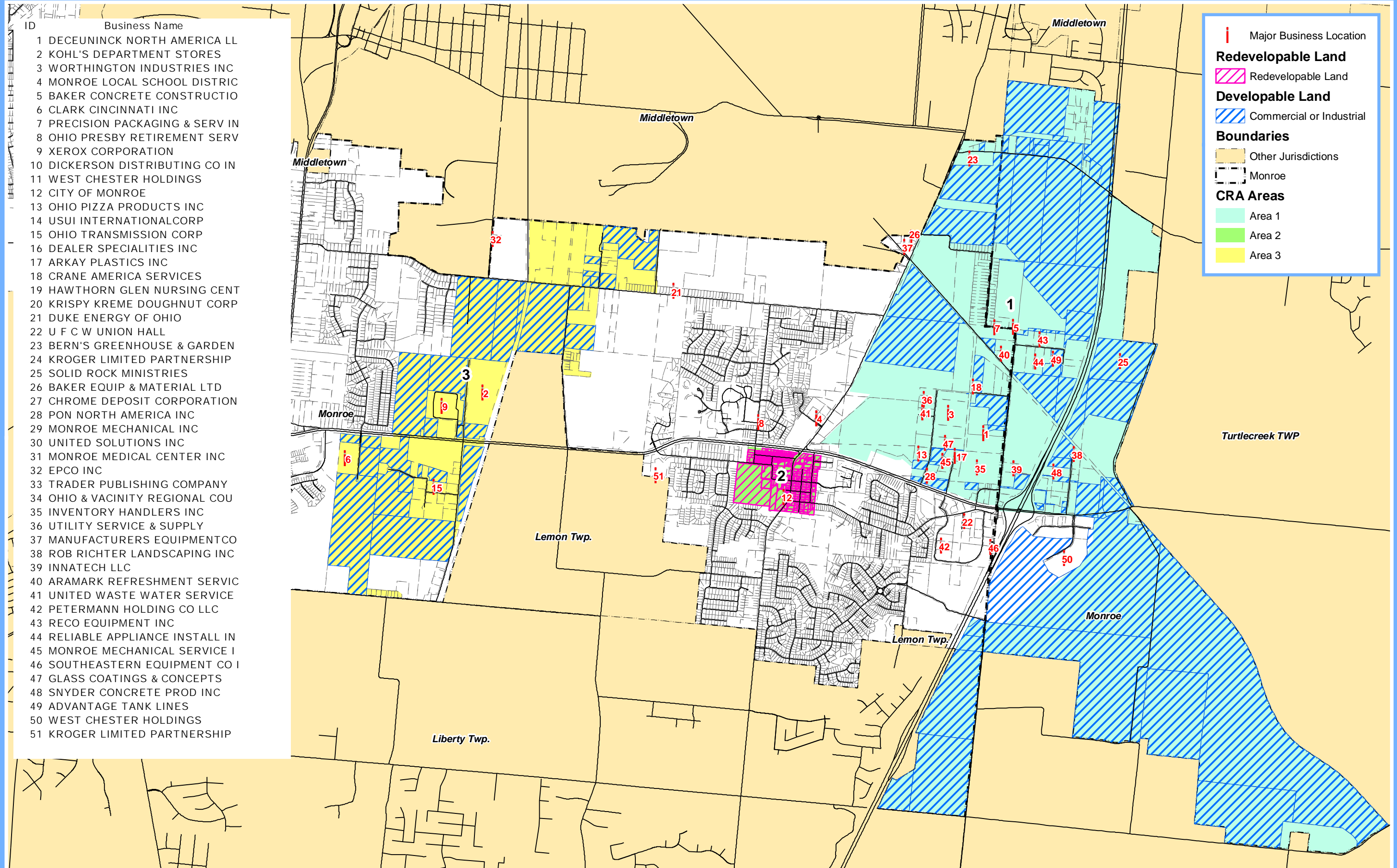


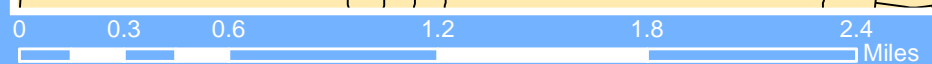
MAJOR BUSINESS LOCATIONS AND RE/DEVELOPABLE AREAS MAP
