Trustees Meeting

At their September meeting, the trustees discussed that the current trash hauling contract ends Oct. 31 but Rumpke billed, and most residents paid, through November. The trash hauling contract is being advertised and bids will be opened at the October 5 trustees meeting. If Rumpke is not the successful bidder, they will have to refund the extra month's payments.

The trustees decided to join the Mid-Ohio Regional Planning Commission's Big Walnut Watershed Planning District.

Road Work

Road Superintendent Doug Crawl reported to trustees that he has sprayed and mowed along all township roads.

If anyone knows of any scouts in need of a service project, ask them to contact Crawl regarding sprucing up the Blue Church bell and creating a memorial garden. Crawl drafted cemetery rules for the trustees to review.

Zoning News

The Zoning Commission is reviewing the draft of the Zoning Code. The township's zoning attorney will review the document as well.

One new accessory building permit was issued on Rosecrans Rd. A complaint was received about uncut grass, debris, and

assorted junk at a property on State Route 61. A letter was sent regarding erection of an unpermitted accessory building on Kilbourne Road.

A hearing was held August 31 on a variance request on State Route 61 to construct a 24' X 32' pole building. A variance to the 25' side yard setback was granted.

Zoning Commission Vacancy Extension

No candidates were available for interviews at the Trustees September meeting, so applicants have an additional month to apply for the Zoning Commission Position.

The Kingston Township Board of Trustees will appoint one position on the Kingston Township Zoning Commission. The five-year appointment runs through August 2015. Interested Kingston Township residents should submit a letter of interest along with a resume to the Kingston Township Zoning Office prior to Friday, October 1, 2010.

The Zoning Commission meets on a monthly basis and deals with matters related to the Kingston Township Zoning Resolution, the Kingston Township Comprehensive Plan/Zoning District Map and other duties as defined within Chapter 519 of the Ohio Revised Code.

Applicants will be interviewed by the Board of Trustees during their monthly meeting on Tuesday, October 5, 2010, 7:30 P.M. at the Kingston Township Hall. The applicant must be present to be considered for the position. Please contact the Zoning Office at 740-524-0290 with questions.

Fight Fire with Facts

Bedroom Fire Prevention and Home Fire Safety

About 3,500 Americans die each year in fires and about 20,000 are injured. You **can** stop the fire before it starts. Use this fact sheet to learn how to prevent a fire in your home and know what to do if you have a fire.

Stop a bedroom fire before it starts:

1. **NEVER** smoke in bed.
2. Replace mattresses made before the 2007 Federal Mattress Flammability Standard.
3. Keep lighters and matches in a locked drawer or cabinet out of reach of children. Children are one of the highest risk groups for death in home fires.
4. Do not run electrical cords under your bed or trap them against a wall where heat can build up. Never put too many plugs into an extension cord.
5. Keep lit candles away from bedding, curtains, papers, and anything else that can catch fire easily.
6. Take extra care when using space heaters. Keep bedding, clothes, curtains, and other flammable items at least three (3) feet away from them.
7. Only use laboratory-approved electric blankets and warmers. Check to make sure the cords are not worn away or coming apart.

Be prepared for a fire:

1. One of the best ways to protect yourself and your family is to have a working smoke alarm that can sound fast for both a fire that has flames, and a smoky fire that has fumes without flames. It is called a "Dual Sensor Smoke Alarm." A smoke alarm greatly reduces your chances of dying in a fire.
2. Make sure everyone in your family knows at least two (2) escape routes from their bedrooms.
3. Make and practice a home fire escape plan and set a meeting place outside.
4. In case of a fire, stay low to the ground beneath the smoke.

Get out, stay out.

Household Hazardous Waste

You can drop off your household hazardous waste at the Delaware County Fairgrounds, 236 Pennsylvania Ave., Delaware 43015 on Saturday, Oct. 23, 9 a.m.-2:30 p.m.

Accepted items include:

- **Electronics** - cell phones, computers, monitors, and other components;
- **Flammables** - adhesives, flares, gasoline, kerosene, lighter fluid, motor oil and filters, propane cylinders (20 # max.), and turpentine;
- **Corrosives** - acids, caustics, car batteries, drain cleaners, household batteries, and pool chemicals;
- **Reactives** - ammunition (50 cal. or less), cyanide, fertilizers, and pool chlorine; and,
- **Toxics or Poisons** - ammonia, antifreeze, bleach, brake fluid, insect killers, mercury, rat poison, transmission fluid, and weed killers.

No televisions or paint will be accepted. No tires will be accepted without payment (\$1-25 depending on size). For more information on unacceptable items, visit
