

NOTICE FOR BIDS

Sealed bids, in accordance with Lake Township's plans and specifications for the Masonry Labor portion and Electrical portion for the construction of a Truck Storage Building for Lake Township at 1499 Midway Street NW, Uniontown, OH 44685, will be received at the office of the Lake Township Trustees, 12360 Market Avenue, North, Hartville, Ohio, 44632, until 4:30 P.M., local time, on Monday, September 12, 2011, and they will be publicly opened and read aloud at 6:30 P.M. on the 12th day of September, 2011 at the Lake Township Hall, 12360 Market Avenue North, Hartville, Ohio, 44632. Bid envelopes shall be marked "**Re-Bid of Certain Portions of Truck Storage Building for Lake Township**".

On and after Monday, August 29, 2011, from 8:00 am to 4:30 pm, Monday through Friday, plans and specifications are on file for review at, and copies of plans and specifications may be obtained from the Lake Township Administrative Office, 12360 Market Avenue, North, Hartville, Ohio, 44632.

Contractor(s) responsible for obtaining permits.

Each bid shall be in conformity with the Revised Code of Ohio and shall contain the names of every person and company interested therein.

Each bid shall be accompanied by a proper certificate by corporation not chartered in Ohio, testifying that such corporation is authorized to do business in Ohio.

Each bid shall be accompanied by a bid guaranty in the form of 1) a certified check, cashier's check or letter of credit, equal to 10% of the bid; or 2) a bid guaranty bond for the full amount of the bid; both forms of guaranty as provided in Chapter 153 of the Ohio Revised Code and in the Project Specifications. The amount of the Bid for said guaranty purposes shall include all additive and deductible alternates. All bid guaranties shall be conditioned that if the bid is accepted within sixty (60) days of the bid opening a contract shall be executed and secured by an approved Performance Bond for one hundred percent (100%) of the contract; and in event of default said bond or check and the amount represented thereby shall be forfeited to the Lake Township Board of Trustees as security.

Bidders shall comply with the Affirmative Action - Equal Employment Opportunity Requirements set forth in the specifications. A bidder/contractor will be deemed committed to the goal of such bid conditions by submitting a properly signed bid. Each bidder must insure that all employees and applicants for employment are not discriminated against because of race, color, religion, sex, handicap, or national origin. Construction work shall be subject to the prevailing wage rates established by the Ohio Department of Industrial Relations.

Terms of payment shall be as provided in Chapter 153 of the Ohio Revised Code

Work shall not begin prior to authorization in writing by the Board of Lake Township Trustees.

The Lake Township Trustees reserve the right to reject any or all bids, to waive any informalities or irregularities in the bids received and to accept any bid or combination of bids which is deemed most favorable to the township at the time and under the conditions stipulated.
